


In January, the study, *Future Directions for Transportation in Pennsylvania* was published. This document provided a brief overview of the critical transportation challenges and opportunities related to transportation that Pennsylvania will face over the next decade. The TAC focused on PennDOT organizationally as the lead transportation entity in the Commonwealth and recommended a major initiative to develop a long-range funding strategy for transportation over the next decade and beyond.

The *Automated Red Light Enforcement Program*, or ARLE is a recent program aimed at enhancing motorist and pedestrian safety through improved technology and operations. In 2002, Philadelphia became the only Pennsylvania city authorized to operate an ARLE program. Current legislation authorizing red light enforcement in Philadelphia expires on December 31, 2011. The Review Team performed an objective analysis of the Philadelphia program and provided recommendations as to whether such a program could be sustained statewide.

The TAC performed the study, *Financial Needs of Counties and Municipalities of Highways and Bridges* to better understand the needs and requirements of the system of local roads and bridges in relation to the financing of the system. This was the most comprehensive analysis of the local system that has ever been conducted.
